July 31st Meeting Recap & Update on Hybrid-Wolf Dogs

On Thursday July 31, GDNA hosted Roanoke City Traffic in which Dwayne D'Ardenne and Rob Issem provided an overview of <u>Vision Zero Roanoke</u> as well as some specifics related to traffic concerns within Greater Deyerle. The presentation is available here (under July 31 meeting minutes).

The other key issue discussed was related to the safety threat posed by the hybrid-wolf dogs on Windsor Rd. Sandra Ryals - who has been spearheading efforts for the City of Roanoke to take action - provided an account of the June 26th incident. GDNA President Adam Mastrangelo provided information about additional attacks, as well as information regarding the fact that the owners are operating a hybrid-wolf dog breeding business out of their home on Windsor Rd. A resolution was proposed, seconded and unanimously approved that 'GDNA supports the City of Roanoke's efforts to remove the Canine Hybrids at 3580 Windsor Road SW from our neighborhood'

On Monday, August 4th @ 9 a.m., Timothy Spencer, City Attorney gave a briefing before City Council on the Proposed Code Amendment, <u>Division IV</u>, Hybrid Canines, Sections 6-55-57, Article II, Chapter 6, <u>Animals and Fowl.</u> Mr. Spencer hopes to have the amendment completed for City Council on August 18th; but, if extra time is needed, then he will have it completed on September 2nd. Regarding the pending charges against the owners - The court case was continued in advance by the defense attorney. Next scheduled for Tuesday, September 9, 2025, @ 2:00 pm.

Bear Sightings in GDNA

Black Bear cubs have been spotted within the Greater Deyerle Neighborhood. Bears are attracted to food sources in residential areas. Here are a few helpful tips from the Virginia Department of Wildlife Resources: ©2025 GDNASM 2

- Store garbage indoors, in a shed or garage, or in a bear-resistant container. Put garbage out on the morning of pickup, not the night before.
- Clean your outdoor grill often. Do not dump drippings in your yard
- Remove bird feeders if a bear is in the area. Bears consume seeds and nuts found in the wild, so bird feeders can become a favored target for bears.
- Don't leave pet food outdoors.
- Do not put meat scraps in the compost pile. Keep compost away from the house.
- Pick up and remove ripe fruit from fruit trees.
- Talk to your neighbors. Make sure your neighbors and community are aware of these recommendations.
